This Post-Effective Amendment No. 2 on Form S-8 pertains to the shares of the Class A Common Stock of Marriott International, Inc. ("Marriott" or the "Company") originally registered on the Registration Statement on Form S-4, as previously amended and as amended by the Post-Effective Amendment No. 1 on Form S-8 (the "Registration Statement"), to which this filing is an amendment. As described in the "Introduction" below, this Post-Effective Amendment No. 2 on Form S-8 is being filed to provide that a portion of the shares of Common Stock originally registered on the Registration Statement for offer and sale to participants in the Starwood Hotels & Resorts Worldwide, Inc. Savings and Retirement Plan (the "Starwood 401(k) Plan") may be offered and sold under the Marriott International, Inc. Employees' Profit Sharing, Retirement and Savings Plan and Trust. This Post-Effective Amendment No. 2 on Form S-8 does not register any additional shares of Common Stock. The registration fee in respect of such shares of Common Stock was previously paid at the time of the original filing of the Registration

Statement on Form S-4 relating to such Common Stock.



## INTRODUCTION

Marriott International, Inc., a Delaware corporation (“Marriott” or the “Company”), hereby further amends its Registration Statement on Form S-4, Registration No. 333-208684, as previously amended and as amended by the Post-Effective Amendment No. 1 on Form S-8 (the “Registration Statement”). This Post-Effective Amendment No. 2 on Form S-8 is being filed by the Company solely to reflect that the Starwood Hotels & Resorts Worldwide, Inc. Savings and Retirement Plan (the “Starwood 401(k) Plan”) was merged (the “Merger”) with and into the Marriott International, Inc. Employees’ Profit Sharing, Retirement and Savings Plan and Trust (the “Marriott Plan”), effective as of June 30, 2018. Effective as of the date of the Merger, the Company’s Class A Common Stock registered on the Registration Statement is being offered under the Marriott Plan, as reflected on the cover page of this Post-Effective Amendment No. 2 on Form S-8. As of the date of the Merger, \$498,872,658.32 remains available under the Registration Statement for offer and sale pursuant to the Marriott Plan.

Following the Merger, Marriott will continue to offer and sell shares of the Company’s Class A Common Stock to accounts of eligible employees of the Company under the Marriott Plan. The Company has previously filed with the Securities and Exchange Commission a registration statement on Form S-8 (File No. 333-166703) on May 10, 2010 registering \$250,000,000 worth of Class A Common Stock issuable under the Marriott Plan and an indeterminate amount of interests in and to be offered or sold pursuant to the Marriott Plan, a registration statement on Form S-8 (File No. 333-202173) on February 19, 2015 registering \$580,000,000 worth of Class A Common Stock issuable under the Marriott Plan, a registration statement on Form S-8 (File No. 333-209589) on February 18, 2016 registering \$670,000,000 worth of Class A Common Stock issuable under the Marriott Plan, a registration statement on Form S-8 (File No. 333-216146) on February 21, 2017 registering \$500,000,000 worth of Class A Common Stock issuable under the Marriott Plan, and a registration statement on Form S-8 (File No. 333-223052) on February 15, 2018 registering \$700,000,000 worth of Class A Common Stock issuable under the Marriott Plan. This Registration Statement is in addition to and does not affect such additional registration statements.

Item 6. Indemnification of Directors and Officers.

Articles Eleventh and Sixteenth of the Company's Restated Certificate of Incorporation (the "Certificate") and Section 7.7 of the Company Amended and Restated Bylaws limit the personal liability of directors to the Company or its shareholders for monetary damages for breach of fiduciary duty. These provisions of the Company Certificate and Bylaws are collectively referred to herein as the "Director Liability and Indemnification Provisions."

The Director Liability and Indemnification Provisions define and clarify the rights of individuals, including Company directors and officers, to indemnification by the Company in the event of personal liability or expenses incurred by them as a result of litigation against them. These provisions are consistent with Section 102(b)(7) of the Delaware General Corporation Law (the "DGCL"), which is designed, among other things, to encourage qualified individuals to serve as directors of Delaware corporations by permitting Delaware corporations to include in their certificates of incorporation a provision limiting or eliminating directors' liability for monetary damages and with other existing DGCL provisions permitting indemnification of certain individuals, including directors and officers. The limitations of liability in the Director Liability and Indemnification Provisions may not affect claims arising under the federal securities laws.

In performing their duties, directors of a Delaware corporation are obligated as fiduciaries to exercise their business judgment and act in what they reasonably determine in good faith, after appropriate consideration, to be the best interests of the corporation and its shareholders. Decisions made on that basis are protected by the so-called "business judgment rule." The



business judgment rule is designed to protect directors from personal liability to the corporation or its shareholders when business decisions are subsequently challenged. However, the expense of defending lawsuits, the frequency with which unwarranted litigation is brought against directors and the inevitable uncertainties with respect to the outcome of applying the business judgment rule to particular facts and circumstances mean that, as a practical matter, directors and officers of a corporation rely on indemnity from, and insurance procured by, the corporation they serve, as a financial backstop in the event of such expenses or unforeseen liability. The Delaware legislature has recognized that adequate insurance and indemnity provisions are often a condition of an individual's willingness to serve as director of a Delaware corporation. The DGCL has for some time specifically permitted corporations to provide indemnity and procure insurance for its directors and officers.

This description of the Director Liability and Indemnification Provisions is intended as a summary only and is qualified in its entirety by reference to the Company Certificate and the Company Bylaws, each of which has been filed with the SEC and is included as an exhibit to this Registration Statement.

(b) That, for the purpose of determining any liability under the Securities Act, each such post-effective amendment shall be deemed to be a new registration statement relating to the securities offered therein, and the offering of such securities at that time shall be deemed to be the initial bona fide offering thereof; and



(c) To remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the offering.

2. The undersigned registrants hereby undertake that, for purposes of determining any liability under the Securities Act, each filing of such registrant's annual report pursuant to Section 13(a) or Section 15(d) of the Exchange Act (and, where applicable, each filing of an employee benefit plan's annual report pursuant to Section 15(d) of the Exchange Act) that is incorporated by reference in the registration statement shall be deemed to be a new registration statement relating to the securities offered therein, and the offering of such securities at that time shall be deemed to be the initial bona fide offering thereof.

In the event that a claim for indemnification against such liabilities (other than the payment by the registrants of expenses incurred or paid by a director, officer or controlling person of such registrant in the successful defense of any action, suit or proceeding) is asserted by such director, officer or controlling person in connection with the securities being registered, the registrants will, unless in the opinion of its counsel the matter has been settled by controlling precedent, submit to a court of appropriate jurisdiction the question whether such indemnification by it is against public policy as expressed in the Securities Act and will be governed by the final adjudication of such issue.
