[1] Franklin Templeton Portfolio Advisors, Inc. (“FTP”) may beneficially own these securities pursuant to various

separately managed account investment management arrangements. Under these arrangements, underlying clients

may, from time to time, delegate to FTP the power to vote such securities, in which case FTP has sole voting power.

To the extent that the underlying client retains voting power over any securities, FTP disclaims any power to vote or

direct the vote of such securities.
