- (1) This Form 4 is filed solely to correct the previously filed Form 4 on November 10, 2008 indicating that the price per share of the securities acquired was \$0.55 rather than \$0.00. As stated in the previously filed Form 4, on November 6, 2008, the Reporting Person was granted 150,000 Restricted Stock Units (RSUs) which represent a contingent right to receive one share of the company's common stock. The RSU's were granted pursuant to the 2004 Stock Incentive Plan and are subject to vesting requirements as follows: 1/8 of the grant will vest on June 18, 2009 and thereafter every 6 months over the remaining 4 year period until such RSUs are fully vested on December 18, 2012. Also includes 87,500 RSUs previously granted and reported that are subject to vesting requirements.
