Each performance share award that is outstanding and vested immediately prior to the effective time of the merger was cancelled and was converted into the right to receive the per share merger consideration. Each performance share award that is not so vested immediately prior to the effective time of the merger was cancelled without consideration.

(3) In connection with the merger, the reporting person exchanged these shares for equity of Danube Private Holdings II, LLC having a market value equal to the merger consideration of \$26.00 per share.
