By reason of its position as general partner of certain partnerships, including MHFII, Holdings may be deemed to beneficially own the 560,013 shares of Common Stock which are held by such partnerships, constituting approximately 8.54% of the shares outstanding.
- (iii) SOAM owned directly no shares of Common Stock. By reason of its position as investment advisor, SOAM may be deemed to beneficially own the 640,675 shares of Common Stock which are held of record by clients of SOAM, constituting approximately 9.77% of the shares outstanding.
- (iv) Mr. Maltese directly owned no shares of Common Stock. By reason of his position as Managing Member of SOAM, Mr. Maltese may be deemed to beneficially own 640,675 shares of Common Stock, constituting approximately 9.77% of the shares outstanding.
