Mr. Feld was awarded these shares in lieu of \$17,750 cash compensation for his services as a member of the Board of Directors of Insperty, Inc. (the "Issuer") during the third quarter of 2016, based on a September 30, 2016 closing price per share of \$72.64.

(1) Compensation includes a quarterly director's fee of \$15,250 and a quarterly fee of \$2,500 for serving as a member of the Compensation Committee of the Issuer's Board of Directors. In addition to the shares of common stock awarded, Mr. Feld will also receive \$25.84 in cash.
