IDENTITY OF MEMBERS OF GROUP

Alcantara LLC, a Delaware limited liability company, is the record holder of 3,000,000 shares of Class A Common Stock of MicroStrategy Incorporated ("Class A Common Stock") and 40,017,935 shares of Class B Common Stock of MicroStrategy Incorporated ("Class B Common Stock"), and The Odyssey Trust is the record holder of 400,000 shares of Class B Common Stock. Class B Common Stock is convertible at any time at the option of the holder into Class A Common Stock on a one-for-one basis. Michael J. Saylor is the sole member of Alcantara LLC and a trustee of The Odyssey Trust. Accordingly, Mr. Saylor is the beneficial owner of the shares of Class B Common Stock held of record by Alcantara LLC and the shares of Class B Common Stock held of record by The Odyssey Trust.
