In accordance with the terms of the Restricted Stock Agreements dated January 2, 2013, October 14, 2013, October 14, 2013, as amended, January 2, 2014 and January 2, 2015, 33, 14, 11, 32 and 74 additional shares of restricted stock were received by the reporting person in connection with the Dividend, respectively. The additional shares of restricted stock will vest as follows: 33 shares in even increments over 3 years beginning January 2, 2015, 14 shares in even increments over 5 years beginning October 14, 2019, 11 shares in even increments over 4 years beginning November 30, 2015, 32 shares in even increments over 4 years beginning January 2, 2016 and 74 shares in even increments over 5 years beginning January 2, 2016.
