Election of New Director

On July 13, 2017, the Board of Directors of DTE Energy Company (the “Company” or “DTE Energy”) elected a new director, Robert Skaggs. Mr. Skaggs is a former gas, storage and pipeline executive and most recently served as Chairman and Chief Executive Officer for Columbia Pipeline Group, Inc., through July of 2016. The Board of Directors determined Mr. Skaggs is an independent director under New York Stock Exchange listing standards and the Company's Categorical Standards for Director Independence. There is no arrangement between Mr. Skaggs and any person pursuant to which he was selected as a director. Mr. Skaggs is not a party to any transaction subject to Section 404(a) of Regulation S-K involving the Company or any of its subsidiaries.

Mr. Skaggs will receive 1,000 shares of restricted stock upon his commencement of service as a director pursuant to the Company's 2006 Long-Term Incentive Plan. The shares vest three years from July 14, 2017, the effective date of the grant, and the recipient is not required to pay any consideration. Mr. Skaggs will also participate in the Company's other compensation and benefit programs for non-employee directors which are described on pages 20-21 of the Company's 2017 Notice of Annual Meeting of Shareholders and Proxy Statement which was filed with the Securities and Exchange Commission on March 9, 2017.
