This Amendment No. 4 amends and supplements the Tender Offer Statement on Schedule TO (the Schedule TO) filed by Eaton Vance Municipal Income Trust, a Massachusetts business trust (the Fund) on December 21, 2015, as amended by Amendment No. 1 filed on February 3, 2016, Amendment No. 2 on February 16, 2016 and Amendment No. 3 on February 24, 2016. The Schedule TO relates to the Fund s offer to purchase for cash up to 100% of its outstanding shares of preferred stock, par value \$0.01 per share and a liquidation preference of \$25,000 per share, designated Auction Preferred Shares, Series A, Series B and Series C (the Preferred Stock), upon the terms and subject to the conditions set forth in the Fund s Offer to Purchase dated December 21, 2015 (the Offer to Purchase) and in the Fund s related Letter of Transmittal (the Letter of Transmittal which, together with the Offer to Purchase, as each may be amended and supplemented from time to time, the Offer), copies of which are attached hereto as Exhibits (a)(1)(i) and (a)(1)(ii), respectively to the Schedule TO. The price to be paid for the Preferred Stock is an amount per share, net to the seller in cash, equal to 94.5% of the liquidation preference of \$25,000 per share (or \$23,625 per share), plus any unpaid dividends accrued prior to the date on which the Fund makes payment for tendered Preferred Stock. The information set forth in the Offer to Purchase and the related Letter of Transmittal, filed as exhibits to the Schedule TO, is incorporated herein by reference with respect to Items 1 through 9 and Item 11 of this Schedule TO.

Filed herewith as Exhibit (a)(5)(v) and incorporated by reference is a copy of the press release issued by the Fund dated February 26, 2016, announcing the final results of Preferred Stock tender offer and issuance of new preferred shares.
