**Explanatory Statement**

All of the 177,395 shares of Common Stock of Socket Mobile, Inc. (the "Registrant") under this Registration Statement are to be registered under the 2004 Equity Incentive Plan. This number includes 48,199 shares of Common Stock that were previously reserved for issuance pursuant to the 1995 Stock Plan (the "1995 Plan") of Registrant on a Registration Statement on Form 8-A filed with the Commission on April 11, 1995 and as amended on Form 8-A/A filed with the Commission on June 15, 1995, and were subject to awards under the 1995 Plan that have expired or otherwise terminated without having been exercised.

Article VII of the Registrant's Certificate of Incorporation and Article VI of the Registrant's Bylaws provide for indemnification of the Registrant's directors and officers and authorize indemnification of employees and other agents to the maximum extent permitted by Delaware Law. In addition, the Registrant has entered into Indemnification Agreements with its officers and directors.

court of appropriate jurisdiction the question whether such indemnification by it is against public policy as expressed in the Securities Act and will be governed by the final adjudication of such issue.
