Mr. Eppinger "net exercised" 80,000 options. The options were granted to Mr. Eppinger in March 2005, and were scheduled to expire in

- (1) March 2015. A total of 62,151 shares were withheld by the Company to satisfy the exercise price and taxes associated with the exercise, resulting in a net issuance of 17,849 shares to, and held by, Mr. Eppinger.
- (2) Does not include 160,362 shares held indirectly in a Rabbi Trust pursuant to deferral agreements.
- (3) The option, representing the right to purchase a total of 140,000 shares, vested 25% on 3/15/06, 25% on 3/15/07, and the remaining 50% vested on 3/15/08.
