CARLO PASTERIS APPOINTED AS COMMON REPRESENTATIVE FOR SAVINGS SHARES SHAREHOLDERS

Milan, 16 May 2007 Telecom Italia's Special Savings Shares Shareholders' Meeting, held in Milan today, appointed Professor Carlo Pasteris as common representative.

Professor Carlo Pasteris will remain in office for three financial years, up to the approval of the financial statements as at 31 December 2009.

Professor Carlo Pasteris was born in Turin in 1927. He is registered with the professional association of accountants and auditors (dottori commercialisti e revisore contabile). He has been the common representative of SIP/Telecom Italia's savings shares shareholders since 1986 and is also the common representative for holders of Telecom Italia Media S.p.A. savings shares, as well as Chairman of the Board of Statutory Auditors of Fiat S.p.A. Itالenergia Bis S.p.A., Toro Assicurazioni S.p.A., De Agostini S.p.A., D&B Sapa and he is on the board of Ferrero S.p.A.

- the level of demand for telecommunications services, particularly wireless telecommunication services in the maturing Italian market and for new higher value added products and services such as broadband;

- the ability of the Telecom Italia Group to successfully implement its reorganization;

- the success of Telecom Italia's customer loyalty and retention programs and the impact of such programs on revenues;

- the impact of regulatory decisions and changes in the regulatory environment, including implementation of recently adopted EU directives in Italy;

- the impact of economic development generally on the international business of the Telecom Italia Group and on its foreign investments and capital expenditures;
