**Preliminary Terms**

**Issuer:** Citigroup Global Markets Holdings Inc.  
**Guarantee:** All payments due on the securities are fully and unconditionally guaranteed by Citigroup Inc.  
**Underlyings:** The S&P 500® Index and the Russell 2000® Index  
**Stated principal amount:** \$1,000 per security  
**Pricing date:** January 31, 2019  
**Issue date:** February 5, 2019  
**Valuation dates:** January 31, 2020, February 1, 2021, January 31, 2022, January 31, 2023 and January 31, 2024 (the “final valuation date”)  
**Automatic early redemption:** If, on any valuation date prior to the final valuation date, the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value, the securities will be automatically redeemed on the fifth business day immediately following that valuation date for an amount in cash per security equal to \$1,000 plus the premium applicable to that valuation date. If the securities are automatically redeemed following any valuation date prior to the final valuation date, they will cease to be outstanding and you will not receive the premium applicable to any later valuation date.

The premium applicable to each valuation date will be determined on the pricing date and will be within **Premium:** the ranges indicated below. **The premium may be significantly less than the appreciation of any underlying from the pricing date to the applicable valuation date.**

- January 31, 2020: 11% to 12% of the stated principal amount
- February 1, 2021: 22% to 24% of the stated principal amount
- January 31, 2022: 33% to 36% of the stated principal amount
- January 31, 2023: 44% to 48% of the stated principal amount
- January 31, 2024: 55% to 60% of the stated principal amount

**Maturity date:** Unless earlier redeemed, February 5, 2024  
**Underlying return:** For each underlying on any valuation date, (i) its closing value on that valuation date *minus* its initial underlying value, *divided by* (ii) its initial underlying value  
**Trigger value:** For each underlying, 60% of its initial underlying value  
**Payment at Maturity:** If the securities are not automatically redeemed prior to maturity, you will receive at maturity, for each security you then hold, an amount in cash equal to:

§ If the final underlying value of the worst performing underlying on the final valuation date is **greater than or equal to** its initial underlying value:

\$1,000 + the premium applicable to the final valuation date

§ If the final underlying value of the worst performing underlying on the final valuation date is **less than** its initial underlying value but **greater than or equal to** its trigger value: \$1,000

§ If the final underlying value of the worst performing underlying on the final valuation date is **less than** its trigger value:

\$1,000 + (\$1,000 × the underlying return of the worst performing underlying on the final valuation date)

**If the securities are not automatically redeemed prior to maturity and the final underlying value of the worst performing underlying on the final valuation date is less than its trigger value, you will receive significantly less than the stated principal amount of your securities, and possibly nothing, at maturity. **Hypothetical Payout Table**

<b>If the first valuation date on which the closing value of the worst performing underlying on that valuation date is greater than or equal to its initial underlying value is . . .</b>	<b>. . . then you will receive the following payment per \$1,000 security upon automatic early redemption or at maturity, as applicable:</b>
January 31, 2020	$\$1,000 + \text{applicable premium} = \$1,000 + \$110 = \$1,110$
February 1, 2021	$\$1,000 + \text{applicable premium} = \$1,000 + \$220 = \$1,220$
January 31, 2022	$\$1,000 + \text{applicable premium} = \$1,000 + \$330 = \$1,330$
January 31, 2023	$\$1,000 + \text{applicable premium} = \$1,000 + \$440 = \$1,440$
January 31, 2024	$\$1,000 + \text{applicable premium} = \$1,000 + \$550 = \$1,550$

**Selected Risk Considerations**

If the securities are not automatically redeemed prior to maturity, your payment at maturity will depend on the final underlying value of the worst performing underlying on the final valuation date. If the final underlying value of the worst performing underlying on the final valuation date is less than its trigger value, you will lose 1% of the stated principal amount of the securities for every 1% by which the worst performing underlying has declined from its initial underlying value. There is no minimum payment at maturity on the securities, and you may lose up to all of your investment.
