**Item 8.01 Other Events.**

On June 3, 2010, Waste Management, Inc. (the Company ) commenced an underwritten public offering of \$600,000,000 aggregate principal amount of its 4.75% Senior Notes due 2020 (the Notes ) under the Company s Registration Statement on Form S-3 (No. 333-162059) (the Registration Statement ). The Notes, which will be fully and unconditionally guaranteed by the Company s wholly owned subsidiary Waste Management Holdings, Inc. ( WM Holdings ), were sold pursuant to an underwriting agreement (the Underwriting Agreement ) entered into on June 3, 2010 among the Company and WM Holdings and Banc of America Securities LLC, Barclays Capital Inc., Citigroup Global Markets Inc. and Goldman, Sachs & Co. as representatives of the several underwriters set forth therein.

The Underwriting Agreement includes the terms and conditions for the issuance and sale of the Notes, indemnification and contribution obligations and other terms and conditions customary in agreements of this type. Certain of the underwriters and their respective affiliates have, from time to time, performed, and may in the future perform, various financial advisory, investment banking and commercial banking services for the Company, for which they have received or will receive customary fees and expense reimbursements.

The Notes will be issued under an indenture dated as of September 10, 1997, between the Company and The Bank of New York Mellon Trust Company, N.A. (the current successor to Texas Commerce Bank National Association), as trustee (the Indenture ). The terms of the Notes and the guarantee by WM Holdings will be set forth in an officer s certificate of the Company (the Officer s Certificate ) delivered pursuant to the Indenture. Closing of the issuance and sale of the Notes is scheduled to occur on June 8, 2010.

Copies of the Underwriting Agreement, the Indenture, the Officer s Certificate and the guarantee agreement by WM Holdings are being filed as Exhibit 1.1, 4.1, 4.2 and 4.4 to this Form 8-K and are incorporated herein by reference.
