**POWER OF ATTORNEY**

Know all by these presents, that the undersigned hereby constitutes and appoints each of W. Jefferson Burnett and J. Burke Asher, signing singly, the undersigned's true and lawful attorney-in-fact to:

- (1) execute for and on behalf of the undersigned, in the undersigned's capacity as an officer and/or director of Remington Oil and Gas Corporation (the Company), Forms 3, 4, and 5 in accordance with Section 16(a) of the Securities Exchange Act of 1934 and the rules thereunder;
