This Amendment No. 1 to Schedule 13G (the "Schedule 13G") is being filed on behalf of Sapling, LLC, a Delaware limited liability company ("Sapling"), Fir Tree Recovery Master Fund, L.P., a Cayman Islands exempted limited partnership ("Fir Tree Recovery") and Fir Tree, Inc., a New York corporation ("Fir Tree"), relating to common stock (the "Common Stock") of Freedom Acquisition Holdings, Inc., a Delaware corporation (the "Issuer"), purchased by Sapling and Fir Tree Recovery. Fir Tree Value Master Fund, LP, a Cayman Islands exempted limited partnership ("Fir Tree Value"), is the sole member of Sapling, and Fir Tree is the investment manager of both Sapling and Fir Tree Recovery.

- (a) Sapling and Fir Tree Recovery are the beneficial owners of 2,539,520 shares of Common Stock and 660,480 shares of Common Stock, respectively. Fir Tree may be deemed to beneficially own the shares of Common Stock held by Sapling and Fir Tree Recovery as a result of being the investment manager of Sapling and Fir Tree Recovery.
- (b) Sapling and Fir Tree Recovery are the beneficial owners of 4.2% and 1.1%, respectively, of the outstanding shares of Common Stock. Collectively, the Reporting Persons beneficially own 3,200,000 shares of Common Stock which represent 5.3% of the shares of Common Stock outstanding. These percentages are determined by dividing the number of shares beneficially held by 60,000,003, the number of shares of Common Stock issued and outstanding, as reported in the Issuer's Prospectus filed pursuant to Rule 424(b)(4) with the Securities and Exchange Commission on December 26, 2006.
- (c) Sapling may direct the vote and disposition of 2,539,520 shares of Common Stock. Fir Tree Recovery may direct the vote and disposition of 660,480 shares of Common Stock. Fir Tree has been granted investment discretion over the shares of Common Stock held by Sapling and Recovery.

Fir Tree Value, as the sole member of Sapling, has the right to receive dividends from and the proceeds from the sale of the Common Stock.
