On January 26, 2005, Open Solutions Inc. (the Registrant) issued a press release announcing its intention to commence an offering of senior subordinated convertible notes due 2035 (the Notes) for gross proceeds to the Registrant of approximately \$125 million. The Notes will be offered to qualified institutional buyers through a Rule 144A offering, with an option to the initial purchasers to purchase up to an additional \$18.75 million of gross proceeds of Notes.
