This Amendment No. 4 amends and supplements the Tender Offer Statement on Schedule TO, originally filed with the Securities and Exchange Commission on January 7, 2005, relating to the third party tender offer made pursuant to the offer to purchase and circular dated January 7, 2005 (as amended or supplemented from time to time, the Offer and Circular ) and in the related Letter of Transmittal. Upon the terms and subject to the conditions described in the Offer and Circular and Letter of Transmittal, Glamis Gold Ltd., a British Columbia, Canada, corporation ( Glamis ) is offering to purchase all outstanding common shares of Goldcorp Inc., an Ontario, Canada, corporation ( Goldcorp ), at a purchase price of 0.89 of a Glamis common shares for each outstanding common share of Goldcorp.

On January 17, 2005, Glamis held an informational meeting and conference call in Toronto. Copies of the transcript of such informational meeting and conference call, together with the slide presentation used in conjunction with the informational meeting and conference call are attached hereto as Exhibit (a)(5)(xi) and Exhibit (a)(5)(xii), respectively, and are incorporated herein by reference.

On January 20, 2005, Glamis issued a press release reminding Goldcorp. Shareholders who requires their shares after December 31, 2004 that they can still vote their shares at the Goldcorp meeting. A copy of this press release is attached hereto as Exhibit (a)(5)(xiv) and is incorporated herein by reference.
