The sale was effected on multiple transactions, at various prices, on January 5, 2007, as follows: 172 shares at \$28.89; 100 at \$28.78; 200 at \$28.90; 15,000 at \$28.56; 200 at \$28.83; 100 at \$28.87; 300 at \$28.82; 3,000 at \$28.76; 1,100 at \$28.81; and 300 at \$28.75. The weighted average sale price was \$28.61 per share.
- (3) After giving effect to the transactions reported in this Form 4, Ms. Clark directly beneficially owns 96,225 shares of common stock and 55,877 shares of restricted stock and 2,799,892 shares indirectly through Smart Stuff, Inc. of Build-A-Bear Workshop, Inc.
