- (1) The option vested in four equal installments, beginning on June 11, 2011.
In accordance with the provisions of the Issuer's 2004 Equity Award Plan, the Compensation Committee approved an equitable adjustment to reduce the exercise price of the options to reflect the \$2.75 per share special dividend to be paid on outstanding shares of the Issuer's common stock. The equitable adjustment was effective as of December 10, 2012.
- (3) The options vest as follows: 2,500 on August 28, 2016 and 7,500 on August 28, 2017.
- (4) The restricted stock units were acquired under the issuer's 2004 Equity Award Plan and vest on August 28, 2017. Vested shares are scheduled to be delivered to the reporting person on the vesting date.
- (5) Each restricted stock unit is the economic equivalent of one share of the issuer's common stock.
